- 2. Give examples for the following terms.
- a) Incarceration

If I had committed first degree murder, a common sentencing would be life is prison without parole.

## b) Mitigating Factors

### c) Psychiatric Assessment

c) Unescorted Temporary Absence means the prisoner has escaped from their prison and law enforcers are working on locating and bringing the convicted prisoner back behind bars.

False - Unescorted temporary absence is the brief release from custody to partake in community service or for personal reasons .

4. Give an example of when the term would be used for the following terms.

### a) Retribution

Retribution is the punishment to avenge a crime, ensuring that the offender suffers the consequences of their action. Looking back at history, a common use of retribution would be to chop a thief's hand off for stealing so that they can not steal again.

#### b) Rehabilitation

Rehabilitation is the punishment combined with treatment and training to help offenders function in society. Arresting drug abusers and offering counselling, prescription to help with addiction along with medical treatment is one example of rehabilitation.

## c) Restitution

Restitution is a punishment that requires the offender to pay the victim or society back for the harm or loss suffered. If I had a car accident and accidentally crashed into some fences, I would have to come up with a solution with the homeowner/land owner such as paying for a new fence or building a new one for them.
