Gettens lists his parents as Jerry Gettens, and Susanne Gettens, Both currently alive, though they very rarely interact with each other or Mr. Gettens since their divorce on November 9th 2009. His mother has since declined to make a statement, however, his father has provided a brief family timeline.

Early childhood

Mr. Chay Gettens had lived with both parents up until his their divorce, due to a incident regarding Mrs. Gettens getting caught being unfaithful as well as abusive. At which point Mr. Gettens lived with his Father for the rest of his time in high school. Upon the divorce there was a change in the behaviour of Mr. Gettens, picking up a much more angry persona. He would regularly get drunk before class and pick fights with teachers and anybody he believed could pose a challenge to him. His regular Violence, combined with his rebellious behaviour and frequent threats led to his expulsion on October 4th, 2010.
